## University Open Ended Items

**Open 1** What helped you learn in this course?

Ignoring my dislike of group assignments in general, the practical assignments were a welcome change from the law school routine and provided valuable learning experiences.

The mootng exercises were a great way to apply the concepts we were learning. Both Professor Blackman and Judge Gibson were very effective and engaging speakers and did a great job of teaching us how all these concepts work in practice.

**Open 2** What changes would improve your learning?

The readings were extensive, and lectures moved very rapidly in order to cover the material assigned. By focusing on the most important aspects of each lesson, the overall learning environment could be improved and more time could be spent discussing the practical assignments. Also, the instructors' mastery of the subjects made lectures slightly harder to follow. Perhaps more deliberate lectures or visual aids (outlines, power points) would aid in this area. Overall, it was a very rewarding and valuable class.

I thought it would have been helpful if we spent a little more time on our mootng exercises in class. I think it would have been nice to actually hold mock court sessions as our mootng exercises were very casual. Other than that, I really enjoyed this course and I feel privileged to have taken it.
